Chapter II, Section 2, recording fees are \$.50 per first entry of each dog and Event Service Fees are \$3.50 per entry (not per dog).

Judging begins at 8:00 a.m. Friday and Saturday. Judging begins at 9:00 a.m. Sunday. Judges are limited to 8 hours of combined judging per day. Judge may take her lunch or other breaks at her discretion.

Acknowledgment of entries will be made as soon as possible after entries close. If exhibitor has not received acknowledgement in a timely manner, please notify the Trial Secretary at KKCObedience@outlook.com

Make all checks and money orders payable to: **Kenai Kennel Club**. Trial Secretary assumes no responsibility for cash sent through the mail. NO ENTRY shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. A fee of \$25 will be charged for any returned check.

<u>Entries</u> will close on April 12, 2024 or when the numerical limit or limits have been reached even if closing date has not been reached. No entry(s), shall be added after the closing time and date specified in the premium list. By providing an email address on the entry form, you agree to electronic correspondence for confirmation letter and judging program.

<u>A wait list</u> will be offered to fill openings created by withdrawn entries after the trial's closing date/time. All entries, including wait listed entries, must be received by the Trial Secretary prior to April 12, 2024. No entries may be withdrawn with a refund after closing on April 12, 2024. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

<u>Entry fees</u> shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the show, no refund of entry fee will be made. Notice that the club may cancel the event due to extreme weather conditions. Refunds of \$10.00 or less will not be given for incorrect entry fees.

<u>Bitches in season</u>: Bitches that come in season after the closing date of the obedience trial may have all but \$10.00 of the entry fee refunded upon receipt by the trial secretary of a veterinarian certificate prior to the beginning hour of judging. A written statement must be submitted in writing to trial secretary prior to 30 minutes before judging.

<u>Injures or Death</u>: Dogs that cannot compete due to an injury will be given a partial refund for all but \$10.00. For injured dogs, a signed letter from a vet must be given to the Trial Secretary no later than 30 minutes before the start of judging on the first day of the trial. In the event of a deceased dog, notification (email or written) must be received by the Trial Secretary no later than the start time on the date of the trial and a full refund will be given.

<u>Exhibitors</u> should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

It is the responsibility of the person submitting the entry form to ensure accuracy of data on the entry form. In the event of errors or cancellation, no refund will be given after the published closing date. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused. Transfers will be permitted in accordance with Obedience/Rally Regulations Ch.1 Sec. 16. Transfers must be submitted at least 30 minutes prior to the start of the trial for which the transfer is being requested.

EVENT RULES

<u>All Dogs</u> shall be held on leash except when in the Obedience Ring. There shall be no drilling nor intensive or corrective training of dogs on the show grounds or premises. The use of corrective devices is strictly prohibited on the show grounds. Exhibitors must be governed by any rules or regulations of civil authorities or building parking regulations.

<u>Exhibitors and Handlers</u> will be held responsible for clean conditions in and around their crates and for cleaning up after their dogs.

<u>Judges are Not Required</u> to wait for any dog holding up a class. Owners and handlers alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. Dogs should be present with ample time before their scheduled judging.

THE TRIAL COMMITTEE will use due diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or misfortune, to either dogs or exhibitors participating in the show. **THE WELFARE OF AN EXHIBITOR'S CHILD** is the responsibility of the exhibitor, who must exercise control and restraint over the child while the child is on the show premises. Failure to do so will result in action by the Trial Committee.
